An international event, this diversity day invites actors from all horizons to launch initiatives to illustrate their commitment to diversity through specific and fun actions.

7 organizations selected to receive the visit of the Minister of Family and Integration

Mrs. Corinne Cahen, Minister of Family and Integration and Patron of the Diversity Charter Lëtzebuerg was once again on the ground to visit organizations in action and to attend, among other things, a round table on multiculturalism and the launch of awareness campaigns. The Minister also virtually attended 3 events. The current pandemic has not stopped organizations from mobilizing. Every year, since the creation of the Lëtzebuerg Diversity Charter in 2012, a signing session brings together new organizations wishing to commit to diversity.

The **10th session of the Official Signature of the Diversity Charter**, on the same day, formalized the 26 new members who, despite the current pandemic, have chosen to commit themselves. A symbolic gesture and an important step for the Diversity Charter Lëtzebuerg, which now has **more than 200 signatories**.
